



Simplified OmniLyse™ Protocol

Protocol 1: Sample Withdrawal Method

1. With the syringe provided, up to 3ml of sample can be processed.
2. Attach the connector of the OmniLyse™ to the battery pack, which should be in the 'Off' position.
3. Insert an empty syringe onto the OmniLyse™ cartridge. Insert the tubing from the other port into the sample. Withdraw sample into the OmniLyse™ cartridge by drawing the syringe up to approximately the 100 µl mark on the syringe.
4. Turn on the motor to begin agitating the sample within the cartridge. Then, begin withdrawing the sample through the cartridge at a slow, steady rate (about 1ml/min or faster). After all the sample has been processed, infuse the sample back through the OmniLyse while 'On' to increase lysis efficiency. Repeat if desired.
